- If your dog is not ASCA registered and you would like to earn ASCA titles, you will need to obtain an ASCA tracking number and include it on the entry form.
- An ASCA Service Membership and Tracking Number Form is included with this premium and is also available at www.asca.org.
- The postmark (not the delivery date) will determine the entry order. Any Express mail entries must include signature permitting them to be left at the Secretary's address without recipient signature.
- There will be a \$25.00 service charge for any returned check. Checks not honored by the bank do not constitute a valid entry fee.
- Confirmations and other communications are sent primarily via e-mail. It is your responsibility to make sure that the secretary's e-mail address of "betsycoleman123@outlook.com" or "hahns7@comcast.net" is allowed by your spam blocker, and to change options that strip attachments from emails.

NOTICE TO EXHIBITORS

This trial is sanctioned by the Australian Shepherd Club of American with Wasatch Working Australian Shepherd Club as the sponsoring club.

Exhibitors, through submission of entry, acknowledge that they are knowledgeable of ASCA rules and regulations, and agree to abide by all rules in effect at the time of this trial including the following:

- All healthy, trained dogs are eligible to compete in ASCA Rally trials.
- Exhibitors should always conduct themselves in a sportsmanlike fashion.
- Bitches in heat, lame or blind dogs are ineligible for entry.
- Any dog which demonstrates aggression towards any person or any dog, whether inside or outside the ring, must be excused from the Rally trial. Any dog which the judge feels is not in sufficient control to perform all the obstacles in a safe manner will be excused from the Rally trial.
- Exhibitors agree that if their dog(s) is (are) left unattended, they will be secured in a crate or x-pen. Owner/handlers whose dogs are tethered or improperly secured will not be allowed on the show grounds.
- No food, toys, tents, crates or other aids or devices shall be permitted within 10' of the ring.
- All dogs shall be on leash when not competing.
- Safety shall always be the foremost consideration in actions and conduct by handlers at all times.
- The sponsoring club will not be responsible for the loss or damage to any dog exhibited, or for the possessions of any exhibitor whether the result is accident or other cause. It is distinctly understood that every dog at this event is in the care and control of his owner or handler during the entire time the dog is on the show premises.
- Any exhibitor whose dogs and/or children create unnecessary disturbances or repeatedly engage in unsafe or disruptive behavior may, at the discretion of the Trial Committee be asked to leave the show site. In such case, no refund of fees paid will be made.
- The organizing committee may not refuse any entry other than on the basis expressly provided through rules and regulations of the sanctioning organization. Anyone not currently in good standing with ASCA will not be allowed to enter the trial.

FREQUENTLY ASKED QUESTIONS

What is the total cost for a QT number?

The cost for membership (required) is \$20 per owner if not already a current member.

- The dog owner's membership expires in one year and only needs to be renewed if applying for another dog after it has expired.
- Owners will need to renew their memberships each year to keep track of their dog's scores/titles in the online member portal. To sign up for an online account, please visit www.asca.org and click "Register" under Member Login (must have member ID#).

Membership fee is in addition to the QT number fee of \$20 per dog.

The QT number for the dog will not expire. If the owner is not a current service member, the total cost for one dog plus one owner's membership is \$40. QT Numbers for two dogs with one owner's membership would be a total of \$60. A QT Number for one dog plus two owners' memberships would be a total of \$60. (This is assuming no owners are current members or under 18).

Do I have to have a QT number to compete?

- You do not need a QT number to compete in ASCA Agility, Stockdog or Dock Jumping events, unless you want to earn ASCA title certificates.
- You must have a QT number to compete in ASCA Obedience, Rally and Tracking Tests.

Why would I need or want a QT number for my dog?

To have ASCA keep track of your scores and receive title certificates for your accomplishments.
